

## Biographies of Participants

**Prof. Henry Farrell** is Professor of Political Science and International Affairs at George Washington University. He is a member of the Council on Foreign Relations, co-chair of the advisory board for the Social Science Research Council's Digital Culture Initiative and affiliated scholar at Stanford University Law School's Center for the Internet and Society. His research interests include European Union and European integration, e-commerce, politics, and blogs. He recently published Weaponized Interdependence (with Abraham Newman; 2019), in: *International Security*, and Linkage Politics and Complex Governance in Transatlantic Surveillance, in: *World Politics*, 70, 4, 515–554.

Prof. Abraham Newman is Professor in the Edmund A. Walsh School of Foreign Service and Government Department at Georgetown University. His research focuses on the ways in which economic interdependence and globalization have transformed international politics. He is the co-author of Of *Privacy and Power: the Transatlantic Struggle over Freedom and Security* (Princeton University Press; 2019), co-author of *Voluntary Disruptions: International Soft Law, Finance, and Power* (Oxford University Press; 2018), author of *Protectors of Privacy: Regulating Personal Data in the Global Economy* (Cornell University Press; 2008), and co-editor of *How Revolutionary was the Digital Revolution: National Responses, Market Transitions, and Global Technologies* (Stanford University Press; 2006). His work has appeared in a range of journals including Comparative Political Studies, International Organization, International Security, Science, and World Politics.

Prof. Dr. Amrita Narlikar is the President of GIGA German Institute of Global and Area Studies and Professor of International Relations at Universität Hamburg. Before coming to Hamburg, she was Reader in International Political Economy at the University of Cambridge. She also has intellectual roots in Oxford, where she read for her M.Phil. and D.Phil. at Balliol, and then held a Junior Research Fellowship at St John's. Her research expertise lies in the areas of international trade, rising powers, and multilateral negotiations. She has authored/edited nine books, including (co-authored) Bargaining with a Rising India (OUP), The World Trade Organization: A Very Short Introduction (OUP), and (co-edited) The Oxford Handbook on the WTO (OUP) and Deadlocks in Multilateral Negotiations (CUP). Her latest book, Poverty Narratives and Power Paradoxes in International Trade Negotiations and Beyond, is currently in production with Cambridge University Press. She has had numerous articles published in international peer-reviewed journals, e.g. International Affairs, Global Policy, International Negotiation, and Third World Quarterly. Amrita frequently provides her expertise to diverse media outlets, recently among others to FAZ, Welt, Süddeutsche Zeitung, and BBC. She also writes a column, "Globale Gedanken", for the German national newspaper Der Tagesspiegel.

**Prof. Daniel W. Drezner** is Professor of International Politics at the Fletcher School of Law and Diplomacy at Tufts University, a non-resident senior fellow at the Brookings Institution, and the author of "Spoiler Alerts" for the Washington Post. Prior to Fletcher, he taught at the University of Chicago and the University of Colorado at Boulder. He has held positions with the Civic Education Project, the RAND Corporation, and the US Department of the Treasury and received fellowships from the German Marshall Fund of the United States, the Council on Foreign Relations, and Harvard University. His latest book, The Ideas Industry: How Pessimists, Partisans, and Plutocrats are *Transforming the Marketplace of Ideas*, was published by Oxford University Press in spring 2017.

**Andreas Cichowicz** has been Editor-in-Chief Television at the Norddeutscher Rundfunk (NDR – Northern German Broadcasting) since 2004 and is responsible for information programmes on NDR and ARD. He is also one of the presenters of the magazine "Weltspiegel" and ARD news and election programmes. Prior to this, he worked as a television correspondent in Southern Africa and later in the Arab world.

Sebastian Groth is Director for Policy Planning at the Federal Foreign Office, where he previously held the positions of Deputy Director for Policy Planning (September 2016 to March 2019) and Director of the State Secretaries' Office (2014 to 2016). Between 2010 and 2014, he acted as an advisor on foreign policy and Franco-German relations in the cabinets of French Prime Ministers François Fillon, Jean-Marc Ayrault, and Manuel Valls. From 2004 to 2010, he worked as an expert on energy and climate policy as well as global economic questions at the Policy Planning staff of the Federal Foreign Office. He started his career at the Federal Foreign Office in 2001 as first secretary at the German embassy in Nairobi (Kenya). Sebastian Groth studied political economy and sociology in Cologne (Germany) and Montpellier (France).

Almut Möller is State Secretary and Plenipotentiary of the Free and Hanseatic City of Hamburg to the Federation, the European Union, and for Foreign Affairs. In the past, she worked as a non-resident fellow at the American Institute for Contemporary German Studies (AICGS) at John Hopkins University in Washington D.C. and was Associate Fellow at the Austrian Institute for European and Security Policy (AIES) in Vienna (Austria). She also was a senior fellow at the European Council on Foreign Relations (ECFR) and head of its Berlin Office. Her research focuses on the development and fundamental issues of the European Union, EU foreign and security policy, and German European policy.

Thorsten Benner is co-founder and director of the Global Public Policy Institute (GPPi) in Berlin. His areas of interest include international organizations (focusing on the United Nations), peace and security, data and technology politics, and the interplay of the US, Europe and non-Western powers in the making of global (dis)order. Prior to co-founding GPPi in 2003, he worked with the German Council on Foreign Relations in Berlin, the UN Development Programme in New York, and the Global Public Policy Project in Washington, D.C. He is an adjunct faculty member at the Hertie School of Governance in Berlin. In the past, he worked with the founding team of the School of Public Policy at Central European University. He is a member of the Global Board of Directors of More in Common and a member of the advisory board of Zahnräder Netzwerk, a platform for Muslim social entrepreneurs. From 2001 to 2003, he was a McCloy Scholar at Harvard's Kennedy School of Government, where he received a master's degree in public administration.

**Tara Varma** is a Policy Fellow and Head of the Paris Office of the European Council on Foreign Relations (ECFR) and Secretary General at Women in International Security (WIIS), France. She joined ECFR in January 2015. Before, she worked for the French MFA in their Shanghai consulate (2012 to 2014), where she helped promote cooperation in humanities and social sciences between French and Chinese universities. Previously, she worked at CEIS, a consultancy firm in Paris, specializing in strategic and defence matters. She graduated from Sciences Po Lille (France) and SOAS in London in International Relations, with a focus on Asian Politics, and Indian and Chinese foreign policies.

**Prof. Eckart Woertz** is Director of the GIGA Institute of Middle East Studies and Professor of Contemporary History and Politics of the Middle East at the Universität Hamburg. His research interests include the political economy of the Middle East and North Africa, energy issues and food security. He previously held positions at the Barcelona Centre for International Affairs (CIDOB), Sciences Po in Paris, Princeton University, and the Gulf Research Center in Dubai. His recent publications include Zurayk, Rami/Woertz, Eckart/Bahn, Rachel (eds.) (2018), *Crisis and Conflict in Agriculture*, Wallingford, Oxfordshire: CABI, and Woertz, Eckart (ed.) (2018), "Wise Cities" in the Mediterranean?, Barcelona: CIDOB.

**Dr. Chad Bown** is Reginald Jones Senior Fellow since March 2018. He joined the Peterson Institute for International Economics as a senior fellow in April 2016. His research examines international trade laws and institutions, trade negotiations, and trade disputes. With Soumaya Keynes, he co-hosts "Trade Talks", a weekly podcast on the economics of international trade policy. Bown is also currently a research fellow at the Centre for Economic Policy Research (CEPR) in London and a member of the Council on Foreign Relations. His work has been published in journals such as American Economic Review, Journal of Economic Literature, Review of Economics and Statistics, Journal of International Economics, and Journal of Development Economics. He is author of the book *Self-Enforcing Trade: Developing Countries and WTO Dispute Settlement* (Brookings Institution Press, 2009), and co-editor, with Joost Pauwelyn, of *The Law, Economics, and Politics of Retaliation in WTO Dispute Settlement* (Cambridge University Press; 2010).

**Apl. Prof. Jann Lay** is Head of GIGA Research Programme "Socio-Economic Development in the Context of Globalisation" and Apl. Professor at the University of Göttingen. His current research involves informal entrepreneurship in developing countries, structural change and its poverty and distributional implications, natural resources, economic development, and conflict. His recent publications include Renner, Sebastian/Lay, Jann/Schleicher, Michael (2019), The effects of energy price changes: heterogeneous welfare impacts and energy poverty in Indonesia, in: *Environment and Development Economics*, 24, 2, 180–200, and Lay, Jann/Nolte, Kerstin (2018), Determinants of foreign land acquisitions in low- and middle-income countries, in: *Journal of Economic Geography*, 18, 1, 59–86.

**Dr. Yu Jie** is Senior Research Fellow on China in the Asia-Pacific Programme at Chatham House, focusing on the decision-making process of Chinese foreign policy as well as China's economic diplomacy. She speaks and writes frequently at major media outlets such as BBC and Financial Times; and regularly briefs senior policy practitioners from the G7 member governments, the UK Cabinet Office and the Silk Road Fund in Beijing, as well as major FTSE 100 corporates. Yu Jie has testified at the House of Commons Foreign Affairs Committee and International Trade Committee, and was also head of China Foresight at LSE IDEAS. She has been recognized as a "Leading Woman" of the London School of Economics for her contribution in teaching and engaging the public debates on China's foreign affairs and remains an associate fellow at LSE IDEAS.

Deputy Ambassador Braz Baracuhy is the Deputy Permanent Representative of Brazil to the WTO in Geneva. He joined the Brazilian Foreign Ministry (Itamaraty) in 2001, and his work has focused on the intersection of foreign policy and economics. His missions abroad include Chief Economic Counsellor at the Brazilian Embassy to China; Trade Negotiator at the Brazilian Mission to the WTO in Geneva; Secretary at the Brazilian Embassy to Peru. In Brasília, he served as the Deputy-Director of policy planning at the office of the Foreign Minister's policy planning staff; Head of the Itamaraty's division of foreign agriculture & commodities trade; Assistant at the policy planning staff; and Assistant Secretary for energy, energy security, and mining affairs. He attended the Grand Strategy Program at Yale University and studied International Relations at the Geneva Institute of International Studies, the Pontifical Catholic University of Rio de Janeiro (PUC-Rio), and the Instituto Rio Branco (Brazilian Diplomatic Academy). He is a frequent lecturer on Economic Diplomacy at the LSE. He has been involved in several initiatives on geopolitics and geopolitical risks.

**Dr. Constantino Xavier** is a Fellow in Foreign Policy Studies at Brookings India in New Delhi and the Brookings Institution in Washington D.C. He researches on India's foreign and security policies as a regional power, with a focus on institutions and decision-making processes, and also on relations with Europe. He is currently writing a book on India's crisis response and involvement in neighboring countries (Nepal, Sri Lanka, and Myanmar), and examining the challenges of connectivity and security across the South Asian and Indian Ocean regions. His research also focuses on how India's democratic values and institutions influence its external engagements and its relations with other democratic powers. He holds a Ph.D. in South Asian studies from the Johns Hopkins University, School of Advanced International Studies.

**Dr. Christian von Soest** is Head of GIGA Research Programme "Peace and Security." His current research focuses on external interventions, in particular international sanctions, the politics of authoritarianism as well as security challenges in sub-Saharan Africa. His recent publications include von Soest, Christian/Grauvogel, Julia (2017), Identity, Procedures and Performance: How Authoritarian Regimes Legitimize their Rule, in: Contemporary Politics, 23, 3, 287–305 as well as Grauvogel, Julia/Licht, Amanda/von Soest, Christian (2017), Sanctions and Signals: How International Sanction Threats Trigger Protests in Targeted Regimes, in: *International Studies Quarterly*, 61, 1, 86–97.

**Dr. Katharina Stasch** currently serves as Minister Heiko Maas' Chief of Staff and Head of Ministers' office. She joined the German Federal Ministry of Foreign Affairs in March 2018 when Heiko Maas came to office. Prior to this, she served as Chief of Staff and Head of the Policy Planning Unit in the Ministry of Justice and Consumer Protection during Heiko Maas' term of office from 2013 to 2018. She studied law and legal anthropology in Hamburg, Aix-en-Provence and London (Master of Laws, LLM) and took her State Exams in 1999 and 2005 (bar exam). Her Ph.D. is on "Lender of Last Resort, banking crises and crises resolution". She started her professional career in the Institute of International and International Private Law at the Universität Hamburg as a research assistant. She has worked as a lawyer for a leading US law firm in the firm's Hamburg before joining the Federal Treasury in Berlin and the Federal Parliament where she held several administrative positions between 2006 and 2013.
