In this workshop, we will explore evolving challenges of cyber resilience in Asia and Latin America, focusing on AI governance, digital authoritarianism, and cyber security alliances. Scientists of GIGA's Digital Transformation Lab (DigiTraL), together with experts in the regions, will discuss how cyber threats, misinformation, and regulatory frameworks can be addressed, and how Germany and the EU can engage in meaningful digital partnerships in Asia and Latin America. Through case studies and cross-regional discussions, we aim to identify policy recommendations and opportunities for international collaborations in the digital sphere.

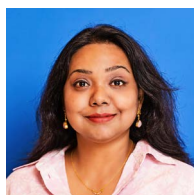

Cyber Resilience in Asia

Cyber Resilience Against AI-enabled Digital Authoritarianism and Disinformation: Lessons from South and Southeast Asia

In her talk, Dr. Sangeeta Mahapatra focuses on the strategies and tactics of cyber resilience adopted by governments and civic actors in South and Southeast Asia against AI-enabled digital authoritarianism and disinformation. She identifies the major risks, proposes a redefinition of cyber resilience based on the emerging threat landscape, and provides cross-learning insights for Germany. Her talk ends with recommendations for potential areas for co-operation between Germany and countries like India and Singapore on cyber resilience against these threats.

Cyber Resilience in Latin America

Digital Resilience in Latin America: Disinformation Trends and Cybersecurity Policy Build-Up

In his talk, Jesus Renzullo explores disinformation campaigns in Brazil, Argentina, Costa Rica, Mexico, and Venezuela, analysing how political actors and state-backed groups manipulate digital platforms. The study investigates organisational structures, objectives, and government pushback against computational propaganda. It highlights the role of fact-checking initiatives, digital literacy, and policy interventions in countering disinformation. The discussion will also focus on cybersecurity alliances in Latin America, examining how governments, civil society, and international actors—such as the EU—can strengthen regional cyber resilience. Recommendations will address policy gaps and explore Germany's role in fostering international cooperation on digital security and governance.

GIGA's Digital Transformation Lab (DigiTraL), funded by the German Federal Foreign Office, analyses the political drivers and real-world consequences of the digital transformation taking place around the world. The Global South in particular is an important actor in and shaper of this transformation. The project concentrates on the following questions in its current phase: Where do individual countries and regions in the Global South stand with regards to digitalisation? Where are the points of contact for (tech)partnerships with Germany? Where are new developments arising (e.g. emerging threats from digital disinformation; related reactions and interventions in the Global South)? What cooperative relationships exist in the field of digitalisation in the Global South, and how can the German government and other stakeholders in Germany best respond to this?
