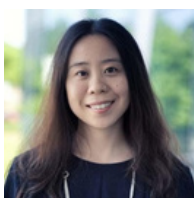
Marites Dañguilan Vitug

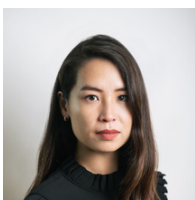
Jayren Teo

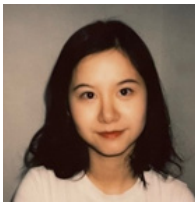
Iris Wieczorek

Minjun Yuan

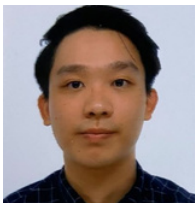

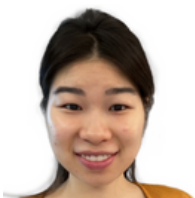
Jun Hui Lee
